White House to Launch Website Exposing Criminal Illegal Aliens Who Have Received Medicaid

QUOTE: The White House launched a website on Monday night exposing criminal illegal aliens, including murderers, rapists, and burglars, who have received taxpayer-funded Medicaid benefits.

The website features mugshots and photos of dozens of illegal aliens convicted of brutal crimes, undercutting Democrat claims that illegal aliens have not received healthcare benefits.

The top of the page chronicles the Trump administration's efforts to crack down on illegal aliens convicted of crimes who have received Medicaid benefits, as well as Democrats' efforts to restore Medicaid benefits to illegal aliens and noncitizens:

The Trump administration has intensified enforcement against criminal illegal aliens receiving taxpayer-funded Medicaid benefits, arresting hundreds of unauthorized individuals since taking office, including those with serious criminal records who exploited taxpayer-funded Medicaid illegally or through loopholes. This crackdown, driven by executive orders prioritizing public safety and fiscal responsibility, has led to the swift deportation of many individuals convicted of heinous acts, ensuring that previous resources meant for American citizens are no longer diverted to subsidize violent criminals.

Compounding the crisis, Democrats have refused to pass a clean budget bill to end the shutdown unless Republicans concede to their demands for \$1.5 trillion in new spending, including restorations to Medicaid expansions that would effectively extend coverage to over 1 million illegal aliens, funneling an additional \$200 billion to such programs over the next decade at the expense of U.S. families. At least five of the t

dozen individuals listed on a glimpse of the page reviewed by Breitbart News were arrested for either murder or manslaughter.

Last Tuesday, for the 13th time, Democrats blocked a clean continuing resolution (CR) to fund the government at 2024 levels approved by then-President Joe Biden and carried over into the 2025 fiscal year. While 52 of the 53 Senate Republicans have supported the CR, the support of 60 Senators is required to break cloture and unlock a floor vote on the resolution, which would then require a simple majority. Three senators from the Democrat caucus, Sens. John Fetterman (D-PA), Catherine Cortez Masto (D-NV), and Angus King (I-ME), have also voted for the bill, meaning five other Democrats are needed to advance it to Trump's desk.

Democrats have been clear about their intentions of forcing a shutdown, with Senate Minority Leader Chuck Schumer (D-NY) declaring on October 9, "Every day gets better for us," during the shutdown, indicating he is putting party over country. Similarly, House Minority Whip Katherine Clark (D-MA), the number two ranking House Democrat, said on October 16 that while families are suffering during the shutdown, "It is one of the few leverage times we have."

BBC Caught EDITING Trump's January 6 Speech to Make It Sound Like He Encouraged Rioting – Here is a Side-by-Side of the Original and Edited Videos

QUOTE: BBC got caught editing Trump's January 6 speech to make it sound like encouraged rioting.

According to The Telegraph, an internal whistleblower memo revealed the BBC "doctored" Trump's speech to make it sound like he was telling supporters to march over to the Capitol and "fight like hell."

The Telegraph reported:

The BBC "doctored" a Donald Trump speech by making him appear to encourage the Capitol Hill riot, according to an internal whistleblowing memo seen by The

Telegraph.

A Panorama programme, broadcast a week before the US election, "completely misled" viewers by showing the president telling supporters he was going to walk to the Capitol with them to "fight like hell", when in fact he said he would walk with them "to peacefully and patriotically make your voices heard".

The "mangled" footage was highlighted in a 19-page dossier on BBC bias, which was compiled by a recent member of the corporation's standards committee and is now circulating in government departments.

The dossier said the programme made the US president "'say' things [he] never actually said" by splicing together footage from the start of his speech with something he said nearly an hour later.

It claimed senior executives and the BBC's chairman had ignored and dismissed a string of serious complaints raised by the corporation's own standards watchdog.

Bondi's revelation is the latest exposure of the investigation into the protests on January 6, 2021, formally known as "Arctic Frost." As part of the investigation, Smeed issued 197 subpoenas to 34 individuals and 163 entities, which included banks and political groups.

European Billionaires Funneled \$2 Billion Via Transatlantic NGO Network To Erode U.S. Democracy, Finance Anti-Trump Protest Machine

- Children’s Investment Fund Foundation (UK) – \$553 million

APT points out that these funding flows exploit gaps in U.S. oversight laws, which prohibit foreign election donations but allow influence through 501(c)(3) and 501(c)(4) organizations. Through the nonprofit world, foreign billionaires can conduct

foreign influence operations through leftist nonprofits, including funding protest industrial complex against Trump, get-out-the-vote drives, anti-Trump ads, lobbying, and whatever else.
