Tennessee Releases Staggering Stats on Migrant Crime

QUOTE: The office of the Tennessee District Attorneys General Conference has released its annual state immigration report revealing that in 2025, illegal migrar committed 2,183 violent offenses, including 41 homicides, 145 sexual offenses, 1 child rapes, and more.

Republican State Rep. Dan Howell said he was shocked by the report and called the data "really, really bad."

"These are the criminals liberals want to defend while trying to defund ICE," he pointed out.

"Forty-one Tennesseans are dead at the hands of illegal immigrants and hundreds raped. This will not be tolerated in this great state and we will do more to keep you safe," Howell added. (emphasis original)

The "2025 Immigration Report" released on January 30 is a required annual report from the state's district attorneys general conference. The law directs them to "collect and analyze data from law enforcement agencies on the number of persons not lawfully present in the United States charged or convicted of a criminal offense in this state during the previous year."

The report found that a total of 21,648 charges were filed against illegal migrants among 11,344 cases between January 1 and December 31 of 2025, averaging nearly 1000 reports per month. However, there are likely even more because one county (Bledsoe) did not submit its data in time for the report to be filed.

Migrants representing a total of 119 different countries were cited in the reports where country of origin was obtainable.

The categories of crimes revealed a shocking toll suffered by the state's citizens at the hands of illegal migrants.

How Senate GOP Can SAVE Trump's Presidency And Wreck Dems

QUOTE: What if I told you Senate Majority Leader John Thune, R-S.D., has the power and the votes — right now — to save Republicans' congressional majority, President Trump's second-term agenda, and maybe the republic itself, all while poleaxing Democrats on the short side of an 84-16 issue?

It sounds like fantasy. But like the Lady of the Lake from Arthurian legend, 2026 is offering up to the GOP a political weapon almost as powerful as Excalibur itself: an extended Democrat talking filibuster of national voter ID legislation.

Requiring voters to prove their citizenship is one of the most popular ideas in the country, with 84 percent of Americans supporting and only 15 percent opposed. That's why 36 states and most of the world's developed countries already have it in the books.

To most Americans, the only thing suspicious about voter ID is why anyone would oppose it. Surely no one wants noncitizens voting, right? Right?

Actually, Democrat leaders, donors, and activists very much want noncitizens voted. Elected Democrats are perfectly aware that the party machine registers ineligible voters and harvests their ballots as a matter of course. They also know that their woke base believes voter ID laws are pure evil, part of Donald Trump's neo-fascist conspirazzzzzzzzzzzz...

Conventional political wisdom, therefore, dismisses voter ID as a legislative nonstarter. Sure, Republicans could pass a bill like the Safeguard American Voter Eligibility (SAVE) Act through the House of Representatives, as they did last April. But Senate Democrats would filibuster it, denying the GOP the 60 votes they'd need to end debate and pass the bill.

But hold on a second.

Why would Republicans want to end an around-the-clock, nationally televised circus where Democrat senators defy 84 percent of the country — and about 70 percent of Democrats! — to defend illegal immigrant voter fraud in the middle of an election year?

Democrats can't politically profit off their extremist ideological commitment against voter ID, but they also can't unload it. A Senate debate on the SAVE Act would force Democrats between a country they can't persuade and a base they can't defy.

For Senate Republicans, the strategy is all upside.

Today, they are staring down the barrel of a midterm election rout and two years of investigations and impeachments. On their current course, Democrats' illegal voter registration programs will continue apace, and their violent, insurrectionist activists will declare victory in 2026 and start working on 2028.

Senate Republicans could reverse all those trends in a matter of days just by putting the House-passed voter ID bill on the Senate floor.

Think about how a voter ID filibuster would play out, politically.

On Day 1, energetic Democrats would run to the floor, thump their chests, and jump the gun. By Day 2, media attention would sweep away all other political news. Left-wing journalists will breathlessly promote the Democrats' cause.

By Day 3, the whole country will have been talking about voter ID — an 84 percent GOP issue — for 48 straight hours. Septuagenarian Democrats will still be on the floor showing off for a shrinking audience of blue-haired hysterics and late-night talk shows' group therapy patients. By Day 4, polling will show the country still supports voter ID. But Democrats' base will demand they keep up the fight.

The hapless filibuster will be a 24/7 Democrat-produced GOP campaign ad that will continue until Democrats surrender.

This is how landmark legislation has always been passed. It's a fiction that Senate majorities start with all the votes they need — that's never the case. Rather, they must make the case, persuade their colleagues, and get the American people on their side. A talking filibuster is a way to check all three boxes, right now, rather than taking a single cloture vote, losing, and throwing up their hands in helplessness.

The only reason for Senate Republicans not to do this — not to save their majority, not to save President Trump's agenda, and the integrity of America's elections — is that it would personally inconvenience them for a few days.

No one in America could possibly think that's a good reason — not the voters are not President Trump.

Migrants Charged in Billion-Dollar Medicare Fraud Scheme.

QUOTE: Federal prosecutors in Chicago have exposed massive Medicare fraud schemes involving foreign nationals (illegals), with more than \$1 billion in fraudulent claims filed for medical equipment and diagnostic tests. Investigators say many of the items were never delivered, authorized, or requested by patients or doctors.

Court filings show that nationals (illegals) from Kazakhstan and Pakistan took control of seemingly legitimate medical supply companies and used stolen patient

information to submit fake prescriptions and bills. Authorities say the perpetrator tried to funnel the proceeds overseas before being stopped.

One of the largest operations involved Kazakh national Anuar Abdrakhmanov, who allegedly submitted \$666 million in Medicare claims in just five months through Priority One Medical Equipment. Investigators found that the company's listed office in Kentucky was mostly empty, with employees forwarding mail to a supervisor they had never met.

Another case centers on Kazakh national Tair Smagul, accused of laundering proceeds from roughly \$953 million in fraudulent claims. Medicare received more than 27,000 complaints from beneficiaries tied to Smagul's operation in Connecticut, with doctors and patients denying any involvement in the billed services.

Two Pakistani nationals are also accused of running schemes using stolen Medicare data to submit false claims through shell companies with names such as Snazzy Sprocket and Peculiar Penguin.

Officials say these cases highlight the growing scope of Medicare fraud, which federal authorities believe may involve billions more in undiscovered false claims

Trump Announces \$12 Billion Strategic Mineral Vault to Challenge Chinese Domination

QUOTE: President Donald Trump announced Monday a \$12 billion strategic mineral reserve to combat China's domination of critical mineral supply chains, a major step toward tackling China's advantage in a crucial sector of the U.S. economy. Trump said the reserve, known as Project Vault, will combine \$10 billion of Export-Import Bank financing and \$2 billion of private sector financing. He expects the structure of the loan to bring in a profit for the U.S. taxpayer while ensuring that companies will not have to worry about the possibility of shortages of critical minerals.

"For years, American businesses have risked running out of critical minerals during market disruptions," Trump said. "Just as we have long had a strategic petroleum reserve and a stockpile of critical minerals for national defense, we are now creating this reserve for American industry," Trump said from the Oval Office, with cabinet officials surrounding him.

"We are taking back critical minerals. We are taking back mining. We're taking back the auto industry. You're gonna watch us take back pharmaceuticals. We're gonna take back semiconductors," Commerce Secretary Howard Lutnick said.

"Project Vault is designed to support domestic manufacturers from supply shock, support U.S. production and processing of critical raw materials, and strengthen America's critical minerals sector," said Export-Import Bank chairman John Jovanovic. "Thanks to President Trump's leadership, the U.S. Strategic Critical Minerals Reserve will help manufacturers in the United States compete, grow, and lead globally while creating jobs domestically, strengthening our economy, and advancing the national interest."

Top executives in the relevant sectors also welcomed the announcement of Project Vault, because it aligns the private sector with U.S. national security imperatives and it promotes domestic manufacturing.

First Major Medical Org Comes Out Against Trans Surgeries for Minors

QUOTE: The American Society of Plastic Surgeons (ASPS) released new guidance Tuesday cautioning physicians against performing gender-transition surgeries on minors, marking a significant breakthrough for critics of the procedures who have long called on major medical associations to be transparent about the harms associated with medicalizing gender dysphoric children.

The new ASPS guidance acknowledges that there is insufficient evidence to prove that irreversible gender-related surgical interventions have longterm benefits for adolescents and therefore recommends that surgeons delay gender-related breast, genital, and facial surgery until a patient is at least 19 years old. The association has expressed "substantial uncertainty" about the longterm benefits of puberty blockers and cross-sex hormones.

ASPS is the first major medical association to clearly disavow gender-transition surgeries for minors. The organization represents more than 11,000 physicians and was founded in 1931.

Other medical associations like the American Academy of Pediatrics (AAP) and American Medical Association (AMA) have remained in support of gender-related care for adolescents.

Like other associations, ASPS supported transition surgeries for years; but in 2021, the group became an outlier when it admitted that there was “considerable uncertainty” about the effects of such surgeries. ASPS is the first organization to alter its guidance based on recent scientific reviews that evaluate the effects of genital mutilation on children.

The report comes days after a landmark medical-malpractice ruling, in which a judge awarded \$2 million to a woman who received a double mastectomy at the age of 16. Doctors rushed to “affirm” plaintiff Fox Varian’s gender confusion with a double mastectomy in 2019, attorneys said during the trial. Dozens more detransitioners — people who received life-altering gender surgeries, in many cases when they were children — have filed similar medical-malpractice lawsuits.
