### **DOJ to Investigate and Arrest Don Lemon and Minneapolis Church Stormers**

**QUOTE:** The Department of Justice has announced that they will be arresting Don Lemon and open investigations into the storming of Cities Church in St. Paul, Minnesota.

Lemon will reportedly be arrested by the Trump administration under the Freedom of Access to Clinic Entrances Act and the Ku Klux Klan Act.

"The Klan Act is one of the most important federal civil rights statutes," said Civil Rights Assistant Attorney General Harmeet Dhillon on The Benny Johnson Show. a law that makes it illegal to terrorize and violate the civil rights of citizens. Whenever people conspire this, the Klan Act can be used."

"Don Lemon himself has come out and said he knew exactly what was going to happen in that facility," Dhillon continued. "He went into the facility, and then he began, quote-unquote, committing journalism, as if that is some sort of shield from being a part—an embedded part of a criminal conspiracy."

Dhillon then confirmed that her office would begin launching investigations into those who took part in the storming of Cities Church after learning the pastor served as a local ICE official, and issued a warning for any would-be copycats.

"Come next Sunday, nobody in the United States should think that they're going to be able to get away with this," Dhillon finished. "Everyone in the protest community needs to know that the fullest force of the federal government is going to come down and prevent this from happening, and put people away for a long long time."

President Trump has come out in support of pursuing lengthy prison sentences for Don Lemon and his alleged co-conspirators.

### **Trump Says He Will Sue JPMorgan Chase Over Debanning**

**QUOTE:** President Donald Trump on Jan. 17 said he intended to file a lawsuit against JPMorgan Chase for what he said were efforts to remove his access to banking following the Jan. 6, 2021, U.S. Capitol breach.

In a post on Truth Social, the president wrote, "I'll be suing JPMorgan Chase over the next two weeks for incorrectly and inappropriately DEBANKING me after the January 6th Protest, a protest that turned out to be correct for those doing the protesting." He also wrote that the 2020 presidential election was rigged against him.

A spokesperson for the banking giant, Trish Wexler, told media outlets in response that JPMorgan "won't get specific about a client" but stipulated that it does not "close accounts because of political beliefs."

Trump did not provide more details about the lawsuit.

In August 2025, Trump issued an executive order to ensure that banks cannot refuse services to individuals based on their political or religious beliefs, a practice known as "debanking." A watchdog in December found that nine large U.S. banks active engaged in the practice between 2020 and 2025.

Advocates against debanking have cited cases of Christians and conservatives who have stated that they have been victims of the practice by major financial institutions, including claims from the Indigenous Advance Ministries, former Sen

Sam Brownback (R-Kan.), and Trump himself, among many others. First Lady Melania Trump, in her memoir "Melania," wrote that she, too, was denied banking services.

"I was shocked and dismayed to learn that my long-time bank decided to terminate my account and deny my son the opportunity to open a new one," she wrote in her book.

#### **Dr. Oz Says Minnesota Fraud Coverup Reaches 'Highest Levels' of State Government**

**QUOTE:** Dr. Mehmet Oz, the administrator of the Centers for Medicare & Medicaid Services, revealed that health care fraud in Minnesota is more significant than previously known.

After speaking to whistleblowers across the state, Oz said there has been a "cover up" for years and that it reaches the "highest levels" of state government.

Oz made reference to Somali Americans and Somali nationals who have a significant presence in the Minneapolis-Twin Cities area, who have recently been accused by administration officials of engaging in the defrauding of federal government entitlement programs, including Medicaid.

"For example, the Somali sub-population, who have different cultural mores than the folks who have historically been in Minnesota, might be taking advantage of systems that were built for 'Minnesota Nice' people," Oz said. "And this is what was told to me by people working in the Department of Health and Human Services there, from folks who are police, law enforcement, they were witnessing it."

The administration has gained "evidence now that we might be seeing that in other Somali populations" in the United States, Oz said, adding that "they talk to each other. Once you figure out that no one's watching the till, you begin to steal more in other areas," he said. "In any case, we are aggressive on this."

Providing an example, Oz said that investigators in the Twin Cities discovered a building with "boarded-up windows" that allegedly had "400 businesses running out of there in the last couple of years that had generated about three \$80 million in bills" for the federal government and Minnesota.

"And these are all social service businesses. So as you start to probe into how this beehive of corruption arose, the question does come up, you know, who owns the building? Like, how did this even come about? The building owner would not let go into the building," he added.

Aside from the Medicare and Medicaid agencies, the Treasury Department also announced last week that it will investigate financial transactions between Minnesota residents and businesses in Somalia, as the government ramps up an operation targeting illegal immigration in the state.



The Department of Homeland Security, too, has deployed thousands of agents to Minnesota as part of that broader federal effort, although protests have erupted recent days over the shooting of a protester.

#### **Our Trash Could Help Us Defeat China**

**QUOTE:** In his escalating attempts to cut ties with China, President Trump has aggressively employed tariffs, threats, and embargoes. But there's one potentially powerful tool the Trump Administration has yet to leverage fully: trash.

Hidden among America's trash heaps and mining waste are potentially rich accumulations of critical materials that China currently monopolizes—and that the United States desperately needs. Capitalizing on those materials will remove one China's greatest sources of leverage over American national and economic secur

Mining operations are highly regulated in America. Companies are required to dispose of waste according to stringent environmental guidelines, leaving little room for startups or entrepreneurial mining companies to leverage the waste for

coproduct generation. Even if they were able to use the waste more effectively, it would be difficult to run a profit because China keeps prices artificially low.

China monopolized the critical mineral marketplace not because it was blessed with stores of minerals that other nations lack, but because it mines and processes the minerals at cut-rate prices by flagrantly ignoring environmental standards. The White House was happy to power our EVs and wind turbines using Chinese-produced mineral as long as the toxic waste sites were kept out of view. Now, with China restricting the flow of critical minerals to the U.S., we don't have the luxury of continuing this devil's bargain.

Successfully, efficiently, and cleanly extracting rare earth minerals from mining waste, coupled with thoroughly recycling electronic devices, will help maximize the American supply of critical minerals.

There is no reason we should be beholden to China for critical minerals. But it's better late than never. Responsible deregulation and investments in mining waste processing can turn our trash into an economic weapon that defeats the Chinese magnet monopoly.
