cooling the world or warming by consuming or driving SUVs beef, to put it simply.




In the year 2000, NASA did release details on its Earth Observatory site about the Milankovitch Climate Theory, exposing that the world is, in fact, altering due to extraneous elements that have definitely nothing to do with human activity. The reality, nevertheless, is far more along the lines of what Serbian astrophysicist Milutin Milankovitch, after whom the Milankovitch Climate Theory is called, proposed about how the latitudinal and seasonal variations of solar radiation that struck the earth in various methods, and at various times, have the best influence on earth's altering environment patterns.

The two images below (by Robert Simmon, NASA GSFC) help to highlight this, with the very first revealing earth at an almost absolutely no orbit, and the 2nd revealing earth at a 0.07 orbit. This orbital modification is portrayed by the eccentric, oval shape in the 2nd image, which has actually been deliberately overemphasized for the function of revealing the enormous modification in range that takes place in between the sun and the earth, depending upon whether it is at perihelion or aphelion.

Variation in Orbital Eccentricity






“Even the maximum eccentricity of the Earth’s orbit – 0.07 – it would be impossible to show at the resolution of a web page,” notes the *Hal Turner Radio Show*. “Even so, at the current eccentricity of .017, the Earth is 5 million kilometers closer to Sun at perihelion than at aphelion.”


The biggest factor affecting earth’s climate is the SUN

When it comes to earth’s obliquity, or its modification in axial tilt, the listed below 2 images (Robert Simmon, NASA GSFC) reveal the degree to which the earth can move on both its axis and its rotational orientation. At the greater tilts, Earth’s seasons end up being far more severe, while at lower tilts they end up being far more moderate. A comparable circumstance exists for earth’s rotational axis, which depending upon which hemisphere is pointed at the sun throughout perihelion, can

considerably affect the seasonal extremes in between the two hemispheres.

Based upon these various variables, Milankovitch had the ability to develop a thorough mathematical design that has the ability to calculate surface area temperature levels in the world going way back in time, and the conclusion is basic: Earth's environment has actually constantly been altering, and remains in a continuous state of flux due to no fault of our own as humans.

When Milankovitch initially advanced his design, it went overlooked for almost half a century. In 1976, a research study released in the journal *Science* verified that Milankovitch's theory is, in truth, precise, and that it does correspond to numerous durations of environment modification that have actually taken place throughout history.

In 1982, 6 years after this research study was released, the National Research Council of the U.S. National Academy of Sciences embraced Milankovitch's theory as reality, stating that:

... orbital variations remain the most thoroughly examined mechanism of climatic change on time scales of tens of thousands of years and are by far the clearest case of a direct effect of changing insolation on the lower atmosphere of Earth.

If we needed to sum the entire thing up in one basic expression, it would be this: The most significant aspect affecting weather condition and environment patterns in the world is the sun. Period. Depending upon the earth's position to the sun at any provided time, environment conditions are going to differ drastically, and even develop extreme irregularities that defy whatever that people believed they understood about how the earth worked.

Rather than welcome this fact, today's environment "researchers," in lockstep with leftist political leaders and a complicit mainstream media, firmly insist that not utilizing multiple-use grocery bags at the grocery store and not having an electrical automobile are damaging the world so rapidly that we definitely should carry out worldwide environment taxes as the option.
