Thousands Of Non-Citizens, Felons Removed From Texas Voter Rolls

QUOTE: Thousands of non-citizens and felons were removed from the Texas voter rolls since the implementation of a 2021 law that has been celebrated as a way to safeguard the state's elections. More than 1 million ineligible voters have been removed from the Lone Star State's voter rolls, Governor Greg Abbott announced yesterday. The cleanup of the voter rolls, which was made possible by Senate Bill 1, resulted in over 6,500 non-citizens and more than 6,000 felons being removed. "Election integrity is essential to our democracy," Abbott stated. "I have signed the strongest election laws in the nation to protect the right to vote and to crackdown on illegal voting. These reforms have led to the removal of over one million ineligible people from our voter rolls in the last three years, including noncitizens, deceased voters, and people who moved to another state."

"We will continue to actively safeguard Texans' sacred right to vote while also aggressively protecting our elections from illegal voting," Abbott went on to state. The announcement from Abbott also noted that the process is ongoing.

In addition to the thousands of non-citizens and felons, the cleanup also resulted in the removal of more than 457,000 deceased people and over 134,000 people who had moved from the voter rolls.

Judge Rules RFK Jr. Can Sue Biden Admin Over Censorship After Supreme Court Rejects Challenge From States

QUOTE: A federal judge on Tuesday ruled that Robert F. Kennedy Jr. can continue to pursue his lawsuit against the Biden administration over censorship at the direction of the government.

The decision comes after a June ruling by the Supreme Court, which established who can sue the Biden administration for violating their First Amendment rights when government officials pressured social media companies to suppress free speech did not have standing to sue.

According to District Court Judge Terry Doughty, Kennedy meets the standard set by the Supreme Court because there is "ample evidence" to show he was censored at the direction of government actors, and is at "substantial risk" that the censorship will continue, the Daily Caller reports.

Kennedy was named by one of the "Disinformation Dozen" - and was specifically targeted by the government over what they alleged was COVID-19 misinformation, Doughty noted in his ruling - adding that there is "not much dispute" that Kennedy, and his organization - Children's Health Defense, were "were specifically targeted by the White House, the Office of Surgeon General, and CISA [Cybersecurity and Infrastructure Security Agency]."

Trust in Vaccines Plummets: Gallup Poll Reveals Seismic Shift in Public Opinion

QUOTE: In a stunning rebuke to public health authorities, a new Gallup poll reveals that American confidence in vaccines has plummeted to historic lows.

This seismic shift in public opinion comes after years of heavy-handed mandates, relentless censorship of dissenting voices, and mounting reports of vaccine-related injuries that were often dismissed or downplayed. As the gap between official narratives and public perception widens, one question echoes across the nation: Has the cure for public health become worse than the disease of mistrust?

Nearly 1K People Attend Christian Revival Led By College Football Stars

QUOTE: Multiple Ohio State star football players led a large Christian revival on the university's campus on Sunday night that attracted between 800 and 1,000 people and resulted in dozens of baptisms. Ohio State running back TreVeyon Henderson, wide receiver Emeka Egbuka, defensive end J.T. Tuimoloau, and former OSU wide receiver Kamryn Babb led the revival service, according to student-run newspaper The Lantern. The event organizers, which included churches from the Columbus area, set up four tubs filled with water where around 60 students who attended the meeting were baptized at the end of the night, The Lantern reported.

During the meeting, the OSU football players talked about their faith in Jesus, and the crowd participated in singing worship songs. Babb, whose playing career was cut short by four ACL-related injuries, discussed how he didn't realize how "broken" he was before he felt "the weight, the love, the grace, the mercy of God wrap [him] like a blanket."

After the players shared their messages, around 50 attendees joined them on stage to pray before many decided to be baptized, according to The Lantern. After people were baptized, volunteers helping with the event led them to a nearby building where they gave them Bibles and helped them read through Scripture.

Lowe's Cuts Ties With Leftist Activist Group, Scales Back DEI Initiatives

QUOTE: Lowe's became the latest major American corporation on Monday to hit the brakes on pushing woke initiatives as conservative customers and activists around the country demand that companies stop adopting Left-wing policies.

Conservative activist Robby Starbuck announced on Monday that Lowe's had announced to its employees that it would no longer be funding "Pride" events or participating in the corporate equality index run by the leftist Human Rights Council. Starbuck said that he had reached out to the retail giant last week asking about its policies.

"Big news: I messaged @Lowe's executives last week to let them know that I planned to expose their woke policies. This morning I woke up to an email where they preemptively made big changes," he posted on X.

The announcement from Lowe's comes after other companies like Tractor Supply and Harley-Davidson have announced a retreat from DEI policies after Starbuck highlighted their policies. Last week, Harley-Davidson said that it had completely discontinued its DEI initiatives.

In an open letter to the public, it said it was no longer implementing DEI policies, was no longer participating in the HRC survey, and would enact strict protocols for future corporate sponsorships and affiliations

"We're now forcing multi-billion dollar organizations to change their policies without even posting just from fear they have of being the next company that we expose," Starbuck said Monday. "We are winning and one by one we WILL bring sanity back to corporate America."

Jack Daniel's Abandons DEI

QUOTE: Brown-Forman Corp., Jack Daniel's whiskey maker, has scrapped its corporate diversity, equity, and inclusion (DEI) programs amid growing pressure from conservatives. In a letter to employees, the Kentucky-based company announced it will no longer tie executive compensation to DEI progress and will end its participation in the annual ranking of LGBTQ-friendly workplaces.

Brown-Forman cited changes in the legal and external environment as reasons for adjusting its DEI efforts.

Previously, 10 percent of short-term executive compensation was linked to DEI goals. The company also scrapped plans to increase minority-owned suppliers.

This move follows similar actions by other corporations that have also faced criticism from anti-DEI activist Robby Starbuck.

Supreme Court Declines to Reinstate \$475 Billion Student Loan Relief Program

QUOTE:The Supreme Court on Aug. 28 turned down President Joe Biden’s request to reinstate a \$475 billion student loan relief plan weeks after an appeals court blocked the program.

Justice Brett Kavanaugh referred the application to the full court, which denied it. No dissents were recorded.

Missouri Attorney General Andrew Bailey hailed the Supreme Court’s decision not to lift the Eighth Circuit’s injunction against the SAVE plan.

“This is the second time the Supreme Court has sided with my office against one of Joe Biden and Kamala Harris’ unlawful student loan cancellation schemes,” Bailey said in a statement.

“This is a huge win for every American who still believes in paying their own way.”
